**Subject : NEW REGULATION NO. 6889 & NO. 7126 OF VIETNAM CUSTOMS FOR  
IMPORT CARGO EFFECTIVE FROM 01 JANUARY, 2019**

We would like to draw your attention for new regulation of Vietnam Customs. All commodities have to be input with TAX code, HS code without any exception to show on EDI and on Bill of Lading from 1 January, 2019 onwards. Kindly please provide us your S/I & amendment details for the following points without failure:

+ **TAX CODE** : Including digits with no space, no special character

(=!'"%&;<>@/?:~-...)

E.g.: 0312798507 or 0312798507001

+ **HS CODE**: at least 4 digits with general cargo & 8 digits with scraps cargo with no space, no special character (=!'"%&;<>@/?:~-...)

Remark : Our system can only accept **10 digits of HS CODE** without any special character, so S/I + amendment should meet this limitation.)

**A. FOR GENERAL CARGO – EFFECTIVE FROM 01 JANUARY, 2019 BASED ON ETA VIETNAM**
